6. The valuations, as established above, shall be binding only with respect to tax year 2013.

7. Brief narrative as to why the reduction was made:


A review of the income and expenses and occupancy of the subject property indicated a reduction in the value of the subject property. The value of the subject is split between residential and commercial.
