STIPULATION (As to Tax Year 2014 Actual Value)

Petitioner and Respondent (collectively, the "Parties") hereby enter into this Stipulation regarding the tax year 2014 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this stipulation.

The Parties agree and stipulate as follows:

1. The property subject to this stipulation is described as:

Also known as: 754 Gore Trail
2. The subject property is classified as **Vacant Land**.
3. The County Assessor originally assigned the following actual value to the subject property for tax year 2014:

4. After a timely appeal to the Board of Equalization (CBOE), the CBOE valued the subject property as follows:


6. Brief narrative as to why the reduction was made:

The stipulated value was negotiated by the Parties for settlement purposes and to avoid the costs and uncertainty associated with a hearing on the matter.

7. The Parties expressly agree that the settled valuation established herein was accepted by the Parties for settlement purposes only, that they have resolved all disputes giving rise to the tax appeal and Petitioner expressly waives any right it may have to initiate a subsequent valuation protest or abatement petition for tax year 2014 relating to the property. The Parties further stipulate and agree that this Agreement does not constitute an admission of liability; that it does not constitute any factual or legal precedent whatsoever; and that it may not be used as evidence in any subsequent proceeding of any kind, except in an action alleging breach of this stipulation agreement.

8. A hearing has been scheduled before the Board of Assessment Appeals for November 24, 2014 at 8:30 a.m. and should be vacated upon the Board's acceptance of this Stipulation Agreement.
