Total	\$463,980

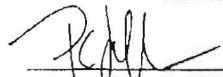
6. The valuations, as established above, shall be binding only with respect to tax year 2012.

7. Brief narrative as to why the reduction was made:

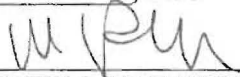
Further review of account data, market sales, lease information and other income/expense data indicated that a change in value was warranted.
