3. The County Assessor originally assigned the following actual value to the subject property for tax year 2015:

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:


7. Brief narrative as to why the reduction was made: The value was adjusted based on market sales and recognition of the actual income on the subject property.
