Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as follows:

2. The subject property is classified as commercial.

STIPULATION (As To Tax Year 2015 Actual Value)


6. Brief narrative as to why the reduction was made:


7. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on April 19, 2016 at 8:30 am, be vacated.


