- 4. The Board concurs with the Stipulation.


ORDER:

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2015.

4. After appeal to the Board of Equalization of the City and County of Denver, the Board of Equalization of the City and County of Denver valued the subject property as follows:

5. After further review and negotiation, the Petitioner and Board of Equalization of the City and County of Denver agree to the following actual value for the subject property for tax year 2015.

Improvements	\$	<u>351,736,400.00</u>
Total	\$	368,668,200.00

6. The valuations, as established above, shall be binding only with respect to tax year 2015.

7. Brief narrative as to why the reduction was made:

A review of the income and expenses and occupancy of the subject property indicated a reduction in the value of the subject property.


