3. The County Assessor originally assigned the following actual value on the subject property for tax year 2013 and 2014.

4. After appeal, Denver County Board of Equalization acting as the Denver Board of County Commissioners valued the subject property as follows:

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization acting as the Denver Board of County Commissioners agree to the following actual value for the subject property for tax year 2013 and 2014.

Total	\$	1,000,000.00

6. The valuations, as established above, shall be binding only with respect to tax year 2013 and 2014.

7. Brief narrative as to why the reduction was made:


A review of the income and expenses and occupancy of the subject property indicated a reduction in the value of the subject property.
