3. The County Assessor originally assigned the following actual value on the subject property for tax year 2016:

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Total	\$1,037,300


6. The valuations, as established above, shall be binding only with respect to tax year 2016.

7. Brief narrative as to why the reduction was made:


Further review of account data, market sales, and income/expense data indicated that a reduction in value was warranted and equalized with the 2015 Order under Docket No. 67557.
