4. The Board concurs with the Stipulation.



The Denver County Assessor is directed to change his/her records accordingly.



<b>STIPULATION (AS TO 2012 ACTUAL VALUE)</b>	

Petitioner, HAMPDEN PRESS, INC., and Respondent, DENVER COUNTY BOARD OF COUNTY COMMISSIONERS, hereby enter into this Stipulation regarding the Tax Year 2012 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

2. The subject property is classified as business-personal property.

3. The County Assessor originally assigned the following actual value on the subject property for Tax Year 2012.

4. After appeal to the Denver County Board of County Commissioners, the Denver County Board of County Commissioners valued the subject property as follows:

6. The valuations, as established above, shall be binding only with respect to Tax Year 2012.

7. Brief narrative as to why the reduction was made:


Taxpayer provided additional documentation supporting the disposal of assets which were assessed during a tax audit by the City and County of Denver. These assets were disposed prior to Tax Year 2012, therefore should not be included in the Tax Year 2012 assessment.

8. Both parties agree to be responsible for their own costs, expert and attorney fees, waiving any claim against each other for such, and agree that any hearing before the Board of Assessment Appeals not be scheduled or be vacated if already scheduled.
