THE PARTIES TO THIS ACTION entered into a Stipulation regarding tax year 2017/2018 valuation of the property listed in this Petition and jointly move the Board of Assessment Appeals to enter its Order based on this stipulation. Negotiations between the petitioner and respondent have resulted in the following agreement:

Subject property is currently classified as **RESIDENTIAL** and is located at: **10035 East 7th Avenue**, County Schedule Number: **1973-03-4-24-013**.

A brief narrative as to why the reduction was made: Comparable market sales, including one sale provided by Petitioner, indicates that adjustment to this value is correct.

The parties have agreed that the 2017/2018 actual value of the subject property should be reduced as follows:

Both parties agree that the hearing before the Board of Assessment Appeals be vacated or is unnecessary if one has not yet been scheduled. Petitioner agrees to waive the right to any further appeal for the assessment year covered by this Stipulation.
