A brief narrative as to why the reduction was made: Comparable market sales in relation to the location of the subject indicates that adjustment to this value is correct.


The parties have agreed that the 2017/2018 actual value of the subject property should be reduced as follows:

Both parties agree that the hearing before the Board of Assessment Appeals be vacated or is unnecessary if one has not yet been scheduled. Petitioner agrees to waive the right to any further appeal for the assessment year covered by this Stipulation.


