**STIPULATION (As to Tax Year 2017 Actual Value)**

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2017 valuation of the subject property and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:  
Lot 162 Highlands Ranch 118-N. 0.247 AM/L.
2. The subject property is classified as Residential property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2017:

Land	\$227,665
Improvements	<u>\$662,295</u>
Total	\$889,960

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$227,665
Improvements	<u>\$637,335</u>
Total	\$865,000

5. After further review and negotiation, the Petitioner and the Douglas County Board of Equalization agree to the following tax year 2017 actual value for the subject property:

Land	\$227,665
Improvements	<u>\$582,335</u>
Total	\$810,000

6. Except as otherwise provided herein, the valuations, as established above, shall be binding only with respect to tax year 2017.


7. Brief narrative as to why the reduction was made:


Parties to the appeal have negotiated mutual recommendation of settlement based on study period market sales.

8. Because 2018 is an intervening year, the parties have further agreed that the 2018 value shall also be adjusted in order to make it consistent with the 2017 value.

9. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on August 29, 2018 at 8:30 a.m. be vacated.
