
4. The Board concurs with the Stipulation.

 The Denver County Assessor is directed to change his/her records accordingly.



5. After further review and negotiation, the Petitioner and Board of Equalization of the City and County of Denver agree to the following actual value for the subject property for tax year 2017.

Improvements	\$	<u>2,346,700.00</u>
Total	\$	2,880,900.00

6. The valuations, as established above, shall be binding only with respect to tax year 2017.


7. Brief narrative as to why the reduction was made:


