Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is located at:

2. The subject property is classified as commercial property.
3. The County Assessor originally assigned the following actual value to the subject property for tax year 2017:

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:
