4. The Board concurs with the Stipulation.


ORDER:

The Douglas County Assessor is directed to change his/her records accordingly.



Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2017 valuation of the subject property and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:
Lot 5A Town of Castle Rock, Amd. 22. 0.48 AM/L.
2. The subject property is classified as Commercial property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2017:

6. The valuations, as established above, shall be binding only with respect to tax year 2017.


7. Brief narrative as to why the reduction was made:


Further review of account data and market sales indicated that a reduction in value was warranted.
