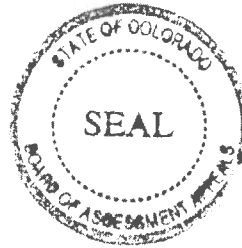

Petitioner, HERBERT BUCHWALD, P.A. and Respondent, DENVER COUNTY BOARD OF EQUALIZATION, hereby enter this Stipulation regarding the tax year 2017 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

2. The subject property is classified as residential real property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2017.

Land	\$	65,000
Improvements	\$	<u>1,537,200</u>
Total	\$	1,602,200

4. After appeal to the Denver County Board of Equalization, the Denver County Board of Equalization valued the subject property as follows:

Land	\$	65,000
Improvements	\$	<u>1,203,500</u>
Total	\$	1,268,500

5. After further review and negotiation, the Parties agree to the following actual value for the subject property for tax year 2017.

Land	\$	65,000
Improvements	\$	<u>1,035,000</u>
Total	\$	1,100,000

6. The valuations, as established above, shall be binding only with respect to tax year 2017.

7. Brief narrative as to why the reduction was made:

A further review of appropriate residential market data indicates a reduction.

8. Both parties agree to be responsible for their own costs, expert and attorney fees, waiving any claim against each other for such, and agree that any hearing before the Board of Assessment Appeals not be scheduled or be vacated if already scheduled.
