**FINDINGS OF FACT AND CONCLUSIONS:**





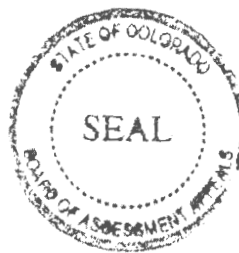
