5. After further review and negotiation, Petitioner(s) and County Board of Equalization agree to the following tax year 2019 actual value for the subject property:

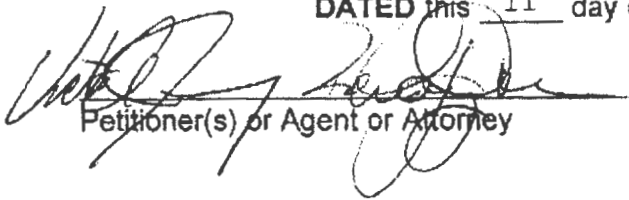

6. The valuation, as established above, shall be binding only with respect to tax year 2019.

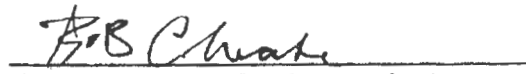

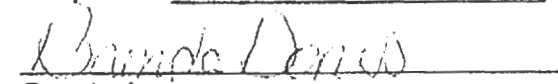
