Petitioner(s) and Respondent hereby enter into this Stipulation regarding the tax year 2019 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this stipulation.

Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this stipulation is described as:

Unit 2 Jenni Exchange Condo

2. The subject property is classified as **Residential** property.

3. The County Assessor originally assigned the following actual value to schedule 6511556 for tax year 2019:

Residential Condo: \$ 873,282

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued schedule 6511556 for tax year 2019 as follows:

Residential Condo: \$ 706,623

5. After further review and negotiation, Petitioners and County Board of Equalization agree to the following tax year 2019 tax value for schedule 6511556:

Residential Condo: \$ 550,378

6. The valuation, as established above, shall be binding only with respect to tax year 2019.

7. Brief narrative as to why the reduction was made:

A review of additional comparable sales and condition of unit indicated a reduction in value was appropriate.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on June 2, 2020, 8:30 a.m. be vacated.
