<b>STIPULATION (As to Tax Year 2019 Actual Value)</b>	

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2019 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is located at:  
2710 Bruchez Parkway, Westminster, Colorado.
2. The subject property is classified as Residential property.
3. The County Assessor originally assigned the following actual value to the subject property for tax year 2019:

Land	\$ 4,505,846
Improvements	<u>\$57,579,926</u>
Total	\$62,085,772

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 4,505,846
Improvements	<u>\$57,579,926</u>
Total	\$62,085,772

5. After further review and negotiation, Petitioner and County Board of Equalization agree to the following actual value for tax year 2019 for the subject property:

Land	\$ 4,505,846
Improvements	<u>\$54,494,154</u>
Total	<b>\$59,000,000</b>

6. Both parties stipulate and agree that the valuation as established above is binding with respect to tax year 2019 and that further adjustment, whether brought under legal or factual grounds, shall be precluded.

7. Brief narrative as to why the reduction was made: A closer look at the market sales and the estimated time trend indicates that the property was previously overvalued.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on July 15<sup>th</sup> at 8:30 a.m., be vacated; or, a hearing has not yet been scheduled before the Board of Assessment Appeals \_\_\_\_\_ (check if appropriate).
