STIPULATION (As to Tax Year 2019 Actual Value)	

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2019 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is located at:
8670 Wolff Court, Westminster, Colorado.
2. The subject property is classified as Commercial property.
3. The County Assessor originally assigned the following actual value to the subject property for tax year 2019:

Land	\$ 550,195
Improvements	<u>\$2,429,506</u>
Total	\$2,979,701

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 550,195
Improvements	<u>\$2,429,506</u>
Total	\$2,979,701

5. After further review and negotiation, Petitioner and County Board of Equalization agree to the following actual value for tax year 2019 for the subject property:



6. Both parties stipulate and agree that the valuation as established above is binding with respect to tax year 2019 and that further adjustment, whether brought under legal or factual grounds, shall be precluded.

7. Brief narrative as to why the reduction was made: The value was adjusted for the condition of the property on 1-1-2019. Taxpayer provided repair costs and those costs were amortized over 5 years. Total repair costs were \$771,032 amortized over 5 years for an adjustment of \$154,206. Base year sale on 11-20-2017 for \$3 Million. Original value of \$2,979,701 less the cost to cure of \$154,206 equals \$2,825,495. Total stipulated value of \$2,825,495. Vintage 1984 year built office property consisting of 35,900 SF.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on September 16th at 8:30 a.m., be vacated; or, a hearing has not yet been scheduled before the Board of Assessment Appeals _____ (check if appropriate).
