<b>STIPULATION (As to Tax Year 2019 Actual Value)</b>	

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2019 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is located at:  
12189 Pennsylvania Street, Thornton, Colorado.
2. The subject property is classified as Commercial property.
3. The County Assessor originally assigned the following actual value to the subject property for tax year 2019:

Land	\$ 543,193
Improvements	<u>\$1,536,058</u>
Total	\$2,079,251

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 543,193
Improvements	<u>\$1,331,807</u>
Total	\$1,875,000

5. After further review and negotiation, Petitioner and County Board of Equalization agree to the following actual value for tax year 2019 for the subject property:

Land	\$ 543,193
Improvements	<u>\$1,256,807</u>
Total	<b>\$1,800,000</b>

6. Both parties stipulate and agree that the valuation as established above is binding with respect to tax year 2019 and that further adjustment, whether brought under legal or factual grounds, shall be precluded.

7. Brief narrative as to why the reduction was made: The petitioner sent interior photos instead of an interior inspection. Reduction is based on this information.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on September 16<sup>th</sup> at 8:30 a.m., be vacated; or, a hearing has not yet been scheduled before the Board of Assessment Appeals   x   (check if appropriate).
