1. The property subject to this Stipulation is described as:

2. The subject property is classified as residential real property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2019.

7. Brief narrative as to why the reduction was made:


A further review of appropriate residential market data indicates a reduction.
