4. The Board concurs with the Stipulation.

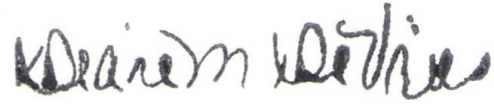
ORDER:

A brief narrative as to why the reduction was made: Income and sales comparison approaches indicate that adjustment to this value is correct.


The parties have agreed that the 2020 actual value of the subject property should be reduced as follows:


