Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2019 valuation of the subject property and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:  
Lot 2 Metzler Ranch Flg 9 1st Amd 1.32 AM/L
2. The subject property is classified as Commercial property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2019:

Land	\$ 747,490
Improvements	<u>\$3,491,150</u>
Total	\$4,238,640

4. After a timely appeal to the Board of Commissioners, the Board of Commissioners valued the subject property as follows:

Land	\$ 747,490
Improvements	<u>\$3,491,150</u>
Total	\$4,238,640

5. After further review and negotiation, the Petitioner and the Douglas County Board of Commissioners agree to the following tax year 2019 actual value for the subject property:

Improvements	<u>\$3,329,510</u>
Total	\$4,077,000


6. Except as otherwise provided herein, the valuations, as established above, shall be binding only with respect to tax year 2019.


7. Brief narrative as to why the reduction was made:

Based on the income approach a minor adjustment was warranted.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on April 28, 2021 at 8:30 a.m. be vacated.
